Note: Customers can use the LHB PA Pay Max premium for tax deduction, whether purchased for themselves or for their parents, subject to the following criteria:

- If purchased for oneself, the deduction is allowed based on the actual premium paid, up to a maximum of THB 25,000 per tax year.
- If purchased for parents, the deduction is allowed based on the actual premium paid, up to a maximum of THB 15,000 per tax year.
